1 **2019-1 One Sovereign Nation**

2 WHEREAS, our United States of America is one sovereign nation, and
3 WHEREAS, open border policies undermine our sovereignty while identity and machine politics
4 destroy our unity by creating and exploiting conflict between groups of our citizens for political gain—
5 pitting old against young, women against men, one race against another, rich against poor, legal
6 immigrant against illegal, city dweller against country dweller, blue collar worker against white collar
7 worker, public employee against private employee, and
8 WHEREAS, recent elections have added to the political turmoil by raising doubts about the integrity of
9 our elections, and
10 WHEREAS, the unity of this ethnically and culturally diverse nation is bound up in the principles
11 defined by the constitutions of the United States of America and those of each state, and
12 WHEREAS these principles have brought the blessings of liberty and justice to generations of American
13 citizens by providing the legal framework that allows us to respond to the will of the majority while
14 defending the rights of the individual, and
15 WHEREAS a nation divided against itself cannot stand,

16 NOW, THEREFORE, BE IT RESOLVED that the Republican Party of Sheboygan County, in caucus
17 assembled, uphold and promote the unifying principles of liberty and justice set forth in the
18 Constitutions of the United States and the State of Wisconsin and refrain from fostering hatred and
19 exploiting division among our citizens, and
20 BE IT FURTHER RESOLVED that we pledge to hold our representatives accountable to their oath of
21 office to protect and defend the Constitutions of the United States of America and the State of
22 Wisconsin and encourage them to promote unifying principles in their political campaigns, and
23 BE IT FURTHER RESOLVED that we call on all publicly funded educational institutions to teach the
24 history and the principles that unify this nation and refrain from planting seeds of hatred and division by
25 promoting various forms of Marxist class warfare and identity politics, and
26 BE IT FURTHER RESOLVED that we rigorously enforce election law to insure that legal citizens vote
27 only once, by creating a chain of evidence to avoid ballot harvesting fraud within the absentee ballot
28 systems; that we examine the potential for fraud in the same-day registration systems; and that we
29 reduce or eliminate lengthy early voting that encourages machine politics, and
30 BE IT FURTHER RESOLVED that the President of the United States defend our national sovereignty
31 by immediately securing our borders, and
32 BE IT FURTHER RESOLVED that Congress encourage legal immigration by taking immediate steps to
33 streamline immigration law; end admission through the loopholes of chain migration, the immigration
34 lottery, and birthright citizenship; and stop providing welfare benefits to those who enter the country
35 illegally, and
36 BE IT FURTHER RESOLVED that Federal legislators enact legislation requiring that only legal
37 American citizens be counted in the 2020 Census as Americans for appropriation of government funds
38 and congressional representation, and
39 BE IT FURTHER RESOLVED that federal law not consider foreign law binding in US courts, and
40 BE IT FURTHER RESOLVED that Congress officially adopt English as the single official language to
41 facilitate selfgovernance in this geographically and culturally diverse nation, and
42 BE IT FURTHER RESOLVED that while we recognize the complexity of global conflict, we call on the
43 Congress and the President to deploy the U.S. military only where there is a clear threat to vital U.S.
44 interests; only to pursue clear goals with clearly stated entrance and exit strategies; and only in situations
45 where the U.S. military personnel will be under U.S. command.



PROPOSED

1 **2019-2 Fifty States--One Federal Constitution**

2 WHEREAS, the United States of America is a constitutional republic established under the Judeo-Christian
3 principle that the Creator has endowed the individual, not the state or politically powerful groups, with certain
4 inalienable rights among which are life, liberty, and the pursuit of happiness, and

5 WHEREAS, the institutions of the traditional family, the church, the local school, volunteer associations, and
6 private businesses are the basis for a free, moral, and prosperous society, and

7 WHEREAS, the Constitution of the United States safeguards the liberty of each individual and free institution and
8 limits federal power to specifically enumerated jurisdictions, and

9 WHEREAS, the Constitution also safeguards this liberty by separating power within the federal government
10 among three branches, requiring that Congress make law, that the President enforce law, and that the Judiciary
11 interpret law.

12 NOW, THEREFORE, BE IT RESOLVED that the Republican Party of Sheboygan County in caucus assembled
13 call upon the **House** to exercise its constitutionally defined fiscal responsibilities by balancing expenses with
14 revenue and implementing zero based budgeting, and

15 BE IT FURTHER RESOLVED we call on the **Senate** to take back its governing role from the administrative state
16 by eliminating those rules that often reduce its function to that of a roadblock both to legislation initiated by the
17 House and judicial and administrative appointments, and

18 BE IT FURTHER RESOLVED we call on **Congress** to end all practices and programs that discourage personal
19 responsibility, self-reliance, and the formation of the traditional family, and

20 BE IT FURTHER RESOLVED we call on **Congress** to devolve to the states or remove from the federal agenda
21 policies and programs that do not comply with the 10th amendment. These would include, but are not limited to
22 individual acts of legislation like the Affordable Care Act, bureaus like the Consumer Financial Protection
23 Bureau, and entire departments like the Department of Education, and

24 BE IT FURTHER RESOLVED we call on **Congress** to respect the rights of the states and the minority by
25 upholding the Electoral College and the constitutional system calling for two senators per state regardless of size,
26 and

27 BE IT FURTHER RESOLVED we call for the **President** to continue with his policy of rejecting previously
28 imposed, unlawful, and destructive executive orders and to re-establish the Congressional authority that was
29 ceded to the President and the administrative state by past presidents, and

30 BE IT FURTHER RESOLVED we call on the **President** to reform the Department of Justice by removing the
31 corrupt appointments of past presidents and prosecuting those who have used that department for political
32 purposes.

1 **2019-3 One Law for All**

2 WHEREAS, our constitutional system — limited government, separation of powers, federalism, and the rights of
3 the people — must be preserved uncompromised, and

4 WHEREAS, the Constitution of the United States and the Constitution of the State of Wisconsin must serve as
5 enduring covenants to be amended only by representatives of the people, not “living” documents to be revised by
6 individual judges and courts, a process that leaves the people at the mercy of the last judicial election or
7 appointment, and

8 WHEREAS, our freedoms depend on the consistent enforcement of the law applied equally and justly to all
9 citizens, and

10 WHEREAS, “all citizens” include the unborn, the infirm, and the elderly, and

11 WHEREAS, the same government that enforces the law must be required to obey the same law,

12 NOW, THEREFORE, BE IT RESOLVED that the Republican Party of Sheboygan County, in caucus assembled,
13 thanks President Trump and Scott Walker for their appointments of conservative judges and thanks Republican
14 lawmakers in the Senate for confirming the same, and

15 BE IT FURTHER RESOLVED that we call on the judiciary to provide equal protection under the law to all
16 citizens, including the unborn, the infirm, and the elderly, and

17 BE IT FURTHER RESOLVED that the judiciary protect citizens and their property from legal abuse resulting
18 from unrestrained court settlements, the abuse of eminent domain law, and the abusive practice of civil forfeiture
19 without due process, and

20 BE IT FURTHER RESOLVED that the judiciary apply the law to end the federal practice of warrantless
21 surveillance in the name of national security and search and seizure misconduct as was seen in Wisconsin’s John
22 Doe investigations and in the endless investigations without probable cause of the Trump administration., and

23 BE IT FURTHER RESOLVED that the judiciary strive to apply the law consistently and leave social engineering
24 and “disparate impact” considerations to legislatures, and

25 BE IT FURTHER RESOLVED that the judiciary strictly enforce our bill of rights and defend us from such
26 attacks as those we now see against rights guaranteed by the 1st and 2nd amendments, and

27 BE IT FURTHER RESOLVED that Congress and government employees be required to abide by the same laws
28 and dictates that apply to all other U.S. citizens.
